The Protech contract was voted on and approved by the Union.

We are continuing and just beginning our negotiations with AFSME- NAC's, EVS, culinary, etc.

We have our first Health Sciences (HSA) scholarship recipient ready to work as a nurse tech. Nurse Techs is a certification through the State. The NT can perform any task they have learned in school. This allows the nursing student to get real life experience outside the classroom. The NT is part of a structured program wherein the employee rotates through the nursing departments. This gives them experience and can inform where they would like to concentrate their practice.

The first Charge Nurse Nash courses occurred the week of March 3rd. We received positive feedback and there was a great turnout. This is mandatory for all charge nurses and the content ranges from inner work to customer service recovery. The course is a series of 3 classes and will be completed in April.

We have been chosen by the DOH to participate in a data quality evaluation of what was reported to NSHN. The high numbers of reported C Diff are of concern and there could be data integrity issues for a number of hospitals. This will allow us to collaborate with the state health department epidemiology program to ensure data accuracy and integrity.

Census in the hospital has remained high. Reaching >20 inpatients for the past couple of weeks.
