1.0 INTRODUCTION



- 1.1 Mason Health (MH) is accepting Proposals from Vendors to:
 - 1.1.1 Furnish custom shelving in the Materials Management Department, supporting the 2023 Campus Master Plan Ph I Project.
 - 1.1.2 Provide design support to the Architect and Owner.

2.0 PROJECT DESCRIPTION

- Project Scope
 - 2.1.1.1 PROVIDE NEW SHELVING/RACKING TO MEET DEPARTMENT NEEDS.
- 2.1.2 Expectations regarding vendor support:
 - 2.1.2.1 Following award to the lowest responsive bidder, the vendor shall be prepared to:
 - 2.1.2.1.1 Provide shop drawings and coordinate with Owner for approval.
 - 2.1.2.1.2 Visit the site as required to meet with the Owner, stakeholders, and the Architect.
 - 2.1.2.1.3 Furnish shelving/racking to match the Owner approved shop drawings, in accordance with the project schedule.
 - 2.1.2.1.4 The Owner has identified existing shelving to be reused. This will be relocated and placed by the Owner. Refer to drawing provided.
 - 2.1.2.1.5 Shelving Requirements:
 - 2.1.2.1.5.1 All new shelving shown assume (5) tiers/levels for each shelf.
 - 2.1.2.1.5.2 Include two dividers per level for each shelf.
 - 2.1.2.1.5.3 For all new shelving shown, include a shelf liner for the bottom tier/level only.
 - 2.1.2.1.5.4 No sharp edges or open-ended wiring allowed without protective caps (to prevent damage to product or staff).
 - 2.1.2.1.5.5 Assume 25% of new shelving shown to include drawers/baskets. Remaining 75% shall be standard multi-tier shelving.
 - 2.1.2.1.5.6 Include sloped shelves for 15% of the new shelving/racking.
- 2.1.3 Schedule:
 - 2.1.3.1 Vendor delivery must align with scheduled completion. For this RFP, only the Materials Management (Area 2.1) section of the schedule applies.
 - 2.1.3.2 Anticipated move-in dates per the project schedule:
 - 2.1.3.2.1 Area 2.1 Materials Management: 9/12/25
- **3.0** INSTRUCTIONS TO BIDDERS

- 3.1 Provide a proposal to furnish all new shelving/racking shown on the drawing.
- 3.2 An optional (non-mandatory) site walk will be held February 28th, @ 11 AM.
- 3.3 Questions due: March 5th, 12pm.
- 3.4 Due date for proposals: March 10th, @ 12pm.

- 3.5 Evaluation criteria:
 - 3.5.1 Mason Health with its Project Manager, OAC Services, will evaluate proposals for completeness and conformance to instructions provided in this RFP. The Owner will award this scope to the <u>lowest responsive bidder</u>. Award is expected to be announced on or before March 12th, by 4pm.
- 3.6 Contract:
 - 3.6.1 Following award, the successful vendor will be issued a Purchase Order from Mason Health to provide shelving/racking and begin work on shop drawings.


